Inadequate pool facility - Kingswood Pool	Swimmers, coaching staff, spectators	Supervising coach (or allotted representative) conducts a “prior to session” assessment of the pool facility prior to session start (including changing rooms, spectator area, water quality [visual] and water/ambient temperature).	Medium	Supervising coach cancels session if pool facility is not adequate. Any hazard/ adverse condition is notified to the school maintenance manager at the earliest opportunity.	Supervising coach	None
Pre session poolside injury, e.g. slips and trips	Swimmers	Ensure compliance with Club NOP. A Teacher/Coach attends poolside at least 10 min. before session start to supervise swimmers. New swimmers	Swimmers	All new swimmers are assessed by lead coach and allotted a group pertaining to their ability. All new swimmers are given a safety brief.	Low	All new swimmers are supervised by an experienced coach.	Supervising coach	None
Injury from training session	Swimmers	Swimmers are given instruction on pool/ lane discipline and etiquette. Coaches have details of any medical conditions or special needs for swimmers in their charge.	Low	Coach has up to date list of any medical conditions or special needs for the swimmers in their charge.	Coach	None
Head first entries	Swimmers	Ensure compliance with Club NOP. Swimmers working towards the ASA Competitive Start Award are closely supervised and monitored on a regular basis.	Medium	Swimmers new to head first entries are given a safety brief.	Coach	None
Safeguarding: mixed age training sessions	Swimmers	Sessions take place in a public pool with public access to all areas, including changing rooms. Alignment with SE coaching policies	Swimmers	Ensure compliance with L2 coach availability for all sessions. Trained coaches are available to each squad.	Low	Head coaches are alert to coach availability, arranging cover as necessary. In the event of non-availability of appropriately accredited staff, session(s) will be cancelled.	Head Coach	Ongoing
Illness/injury resulting from lack of medication	Swimmers	Parents & swimmers to ensure medical conditions are recorded on the membership form. Coaches have details of any medical conditions or special needs for swimmers in their charge.	Low	Coach to ensure swimmer has access to prescribed medicines and has taken in accordance with their prescription, where necessary. Coaches have access to an up to date list of any medical conditions or special needs for the swimmers in their charge.	Coach	Ongoing
