It is only a week and a half a way from the SGM and Executive Committee Meeting and if I could ask for the Executive Committee Reports by 10pm on Thursday the 2nd May. We will start with the SGM on the roles we have vacant and how we will ensure these are filled. I d like to remind everyone that unless we have the 4 main roles filled (namely Chair/Vice Chair, Secretary, Treasurer and Welfare), that we are not considered a functioning Club by Swim England and NOT allowed to run the County Championships or any meet, and also not permitted to run the pathway programmes.

I was pleased to hear that Clubs are already talking to one another about the situation, both the main roles and the running of the County Championships. I hope to be able to start the SGM with a short breakout to allow clubs to share their ideas with one another before we start.

As a reminder the Treasurer and Myself have suggested alternative approaches in addition to the current practice for filling the Chair/Vice Chair and Welfare Roles. In brief:

1. Chair/Vice Chair Rotated around larger Clubs Chairs (Vice Chair for 6 months then move to Chair).

Addition of a County Judicial Officer to assist the Chair and Clubs in Judicial Process.

2. Welfare Panel of 4 Rotated around larger Clubs Welfare Officers and rotated off at each quarter allowing continuity and support for each other.

Last years reported numbers would have Club Support numbers <included in email>

I have requested an updated list.

We are also able to discuss the roles and jobs for the County Championships and hopefully

agree who picks up what.

Please find attached the Agenda(s) for the forthcoming Virtual meeting on Tuesday 7th May 2024 which will start at 7pm.

I should be grateful if:

- 1. All Committee Reports could be sent to me by 10pm Thursday 2nd May this will enable me to send those reports out to Members ahead of the mtg. If you do not have anything to report, please let me know. Please note, I will send all Elected Officers a meeting invite invite.
- 2. Clubs could confirm their attendees and email addresses by no later than 10pm Thursday 2nd May so that I can send zoom invites.

Surely, this must send a clear signal to you that it is time to re-consider the implications of your new requirements. As I said in my email below, surely the possibility of forcing smaller clubs to shut down, and maybe now, the County Association must be completely contrary to everything that Swim England was set up to achieve.

I intend to attend the virtual SGM of ONB it will be interesting to see if any of the other clubs have found themselves placed in the same situation as ourselves.

I re-iterate that we are always fully supervised by the normal, trained, GLL pool staff. They also provide the lifeguard and I am absolutely sure that the GLL staff would step in immediately if anything untoward were to occur. So there is absolutely nothing at all to be gained by having an additional fully trained welfare officer for our club it just doesn't make any sense at all.

Dear Lizzie

Thank you for coming back to me.

I had already tried to contact the county welfare officer for our region (Oxfordshire and North Buckinghamshire) before I contacted you. Apparently that post is currently vacant and remains so, as are a number of other senior posts.

Kate Hutchinson also put me in touch with the welfare officer of another smaller club. We had a nice discussion a few weeks ago, and she sympathised with our situation, but nothing has come of it.

Quite frankly, I cannot see how somebody who doesn t know or visit our club could actually add anything.

Our pool is within easy walking distance of Henley town centre and some members already walk to the pool. As I said in my email, we would be happy to have more members, but nobody seems to want to swim at 8:00am on a Sunday morning.

I just don t see what we have to gain with having a welfare officer in our particular situation.

Having explored all the possibilities, as I mentioned, if you will not allow us to continue to operate as we have done in the past, we will probably be forced to shut down the club which is a great shame and a disappointment after 40 plus years and must be contrary to everything that Swim England was set up to achieve.

I am certain that we are not alone in having this problem.

Hello Tony,

Apologies for the delayed response. I had sent this onto safeguarding to also ensure they had input.

Sorry to hear you feel that some of these requirements are a burden. That is not the intention and we just want to ensure that all clubs are a welcoming and safe space for everyone. We do appreciate that every club is unique in its set up, however this becomes more difficult to manage if every club had different rules and standards. This is why we have the minimum standard which is applicable to all clubs.

I completely understand where you are coming from in respect of the Diversity and Inclusion Action plan and we are pleased to hear you are welcoming to everyone. However it is important that clubs think about their existing members, rather than new members, and how barriers can be removed in order for them to either feel more comfortable or for example be able to get to their weekly swim. For example, as a club, can you signpost local transport routes for those who don t drive? It s thinking outside the box.

In respect of the Welfare Officer and Masters requirements, I would recommend you reach out to your County Welfare Officer as the Welfare Lead for your club instead of having your own as we appreciate you are a small club. You can find your County Welfare Officer contact here to ask if that would be ok as a club to signpost to them:

Subject: Requirements for Welfare Officer for small swimming clubs

Originally sent on 22nd March I don t seem to have received any response!

#### Dear Ms Butcher

I am writing to you to try to explain the difficulties which the latest Swim England requirements are imposing upon small clubs such as ours.

Perhaps I should first explain a bit about our club:

It was originally set up over 40 years ago, by staff from the BBC, Caversham Park, to encourage swimming for their employees over the age of 20. Nowadays, the club is open to all considerate swimmers over 20 years of age. We swim for hour every Sunday morning from 8:00am to 8:30am at the GLL/Better Leisure Centre in Henley-on Thames. We are, as our name suggests, a Leisure Swimming club, primarily aimed at those older people who prefer to swim in a non-crowded pool to keep fit.

We do not compete, we do not have or want any racing, coaching or training, and currently we have only seven members all between 30 and 75 although we try continually to recruit more. Our efforts in this respect have included regular leafleting in the Leisure Centre, a poster in the local library, and we have managed to arrange the occasional supportive article with the local Press.

South Oxfordshire District Council have been very supportive of our efforts to encourage older people to swim and have used their influence to keep our pool hire rates affordable. We operate on a non-profit basis, just to cover our costs. Currently our income is about 330 per quarter. We would like to be able to recruit more members as we are operating just below break-even cost at the moment. We are required by GLL to have independent Public Liability insurance, and have always used membership of the ASA/Swim England to benefit from this. We have been very pleased to be members and support the aims of ASA/Swim England. Our main problem with low membership seems to be that very few people want to get out of bed early on a Sunday morning these days!!

We have never had any safeguarding, disability or other related issues at the club and do not foresee any likelihood of this occurring.

Until recently, we have spent about an hour or so annually, completing the requirements for ASA membership. Over the last 2-3 years, this has increased to about 25-30 hours as the Swim England paperwork requirements have increased. We were, until now, able to use the Masters Exemption to avoid some of the formalities required of larger clubs.

Between James Cushing and myself, we have managed to cover all the paperwork including the latest requirement to have a Diversity Policy. Frankly we are not interested in the class, ethnicity or other background of our members, provided that they are courteous at all times and do not disturb the other members whilst they are swimming.

Then, this year, as you will no doubt be well aware, a raft of further mandatory requirements have been introduced for the Welfare Officer, the Chairman and, I believe, similar additional courses may be in the pipeline for the Secretary and Treasurer.

Unfortunately none of the other five members are very keen to take on any of the additional work of running the club and there is a limit to the amount of time James and I are able to spend on paperwork.

As we only swim for 25 hours per year, I am sure you will understand that the time we are already spending to achieve compliance with the Swim England bureaucracy already exceeds the time we spend swimming. If Swim England insists on imposing these additional new requirements for lectures, workshops, D&B etc. etc, it is very likely that the time taken to comply with your new bureaucratic requirements will be double or more than the time we actually swim for!!

This is becoming an unacceptable (and in my opinion, unnecessary) burden on the volunteers who run our club.

We are always fully supervised by the normal, trained, GLL pool staff. They also provide the lifeguard. I am absolutely sure that the GLL staff would step in immediately if anything untoward were to occur. So I cannot see anything to be gained by having an additional fully trained welfare officer for our club it just doesn t make any sense at all.

I have also spoken to people at other similar sized clubs in the same position as ours, and they too, are finding the new requirements excessive.

So, we find ourselves stuck in this new bureaucratic nightmare which is now being imposed upon us. I just don't think that those responsible for these new policies have properly considered the ramifications for smaller clubs like ours. We were willing to try to comply as far as possible with the requirements imposed until this year and have not complained until now.

I can fully appreciate in the light of recent events, that in larger clubs, and those with younger or disabled members, who train and race etc. there is a requirement for additional training for staff. However, the same one size fits all measures are really not appropriate for clubs in similar circumstances to ours in my opinion.

Surely, it is not beyond the expertise of Swim England to find a more appropriate and suitable arrangement for small clubs like ours? Until now, the Masters Exemption has been perfectly satisfactory. Can you not possible devise some sort associate club membership providing insurance cover with something like the Masters Exemption if the club is 'small' and only uses public facilities with full staffing/lifeguarding provided?

If a more suitable and appropriate alternative for small clubs like ours cannot be found with Swim England we may have no alternative but to shut down the club. This seems a great pity as we have been very pleased to be a part of the Amateur Swimming Association/ASA for well over 40 years now and we all enjoy and benefit from our weekly swim.

I would therefore request that you should please discuss this with senior Swim England staff and look forward to your comments.
