The proposal is, that to avoid too large an impact on smaller clubs and to exclude this year's Chair and Vice Chair, that we make the random selections for Chair and Vice Chair from the largest and most active clubs based on their Competitive Swimmers (Club Compete). Those Clubs with 100 or more Club Compete members, this is from the report provided by Swim England of current membership.

Clubs predominantly leisure or focused on learn to swim have larger Club Train membership; and Club Support is not applied uniformly across all clubs, with many following Swim England guidance and having a parent of every swimmer under 18 as a Club Support Member and some not following this advice and so this does not reflect parental involvement well.

As per the constitution should no one step forward as Chair the role will be randomly allocated to a member Clubs all being eligable.

The constitution has 3 Clubs being assigned randomly:

- 1. Chair: first 6 months
- 2. Vice Chair: 6 months then becomes Chair for second 6 Months
- 3. Vice Chair: for second 6 months

We are also recommending that the role is held for 1 year rather than the 6 months, in this case we would just select 2 clubs who can decide whether to switch roles at 6 months or retain their roles for 12 months.

The random selections will be carried out at the AGM should we not have a volunteer.

Please note, that without the 3 principal officers being elected, the agenda item for the AGM will be the dissolution of ONB and distribution of assets. There will be no County Championships and Clubs will not be reallocated to adjacent Counties automatically (this has been confirmed with Swim England last year). All 3 roles are critical for the running of the County.
