Question: Are the swimming groups changing? Answer: Yes there will be some changes which will be communicated in the New Year.

Question: Are we still going to operate out of 2 sites? Answer: Yes, training at Stroud and Thornbury will continue.

Question: When will we advertise for a Head Coach? Answer: Waiting to develop the Club Development Plan including vision/ethos.

Question: Have we received any contact from other clubs wishing to take over Stroud? Answer: Not at this time.

Question: If a child of a committee member were to leave the club, do they forfeit their position on the committee? Answer: No.

Question: Who should be the first contact for any matters relating to swim injuries? Answer: Keith or the Lead Coach for each group.

Action: Club to share Timetable and Coaching Plans for January

Question: Who is taking responsibility for creating the training plans and sets for the groups at the moment? Answer: Keith Smith for TLC and Caroline Pearson for SPLC.

Question: How often will Keith be coaching? Answer: One session per week at SPLC and one session per week at TLC.

Question: Will the training be individualised for swimmers? Answer: The training will be centred around the schedule for competitions and will include more technical work. Coaches should be able to cater and adapt sets during the sessions.

Question: What is the plan for coaching cover at Thornbury now that David, Sarah and Jo have left the club? Answer: Sara Part and Keith will cover in the interim, alongside Karen, Kath and some further new coaches who will shortly be introduced to swimmers.

Question: What is the plan for communication from the committee and club moving forward? Answer: More transparency, honest and regular communications for all parties.

Question: Can there be a swimmer/parent forum regularly to share information about developments within the club? Answer: Yes, we will explore options for this.
