Meeting Minutes

- Luke Jury is currently working as a level 2 teacher but is looking at doing coaching Level 1 & 2 and would therefore be able to bring in more experience. KB has asked the institute of swimming to see if he can get funding and training £460 full cost with no bursary but could get a bursary if booked through the club.
- We will have Shannon, Ivor and Maddy qualified very soon as Level 2 coaches, with Kay and Matt is planning to do his training asap for his Level 2. LW was asked about Level 3 coaching requirement and he informed the Committee of the need to be selected by the Institute to do a Level 3 coaching. KB to get course for Matt sorted. GS said happy to fund training for Matt and would pay him when he's qualified. Maddy needs to do safer recruitment and DBS.
- RM suggested that we need to be stronger with the membership from a volunteer point of view to ensure we have enough support for our plans going forward.
- NS informed the committee how busy her workflow was over the next few months publicising para swimming as well as regionals and up and coming meets.
- Fee document approval GS confirmed that it had been circulated to the Committee a vote was taken the policy was voted on and unanimously approved GS confirmed that it now includes visitor swimmer amendment.
- GS updated then committee on the status of outstanding fees, 3 swimmers who have left the Clubs with outstanding fees, RM has informed them that Swim England will be informed as per policy.
- GM asked about swimmer invoices about when to invoice for meets GS
 confirmed that he would prefer to invoice at the last minute to avoid having
 to do minutes.
- TB provided a L1 meet update, he explained that we can expect to get a









rush of entries in the week before entries close. Current entries look good with fees and coaches passes orders looking good, the meet is oversubscribed on the Friday night so TB will need to look at scratches. TB is hoping to notify places by Sunday evening so parents and swimmers can plan. Some other sessions also need to be reduced to fit within the time allowances.

- The aim will be to finish before 6pm each day. VN asked about the official's
 position, she stated that were looking good with volunteers for all sessions
 except for the Friday night.
- A discussion as had regarding how we manage swimmers who are on their own (individuals).
 - o <u>KB to find a letter to be sent to swimmers with individual entries to ensure that we have the correct support for them without risking the support for our own swimmers.</u>
- VN provided a_Wave power update regarding L1 coach or swim teachers'
 requirements for meets stating that are acceptable providing a risk
 assessment has been prepared in advance she also stated that in the
 instance that 3 swimmers or less are competing it is acceptable that you
 don't need to have a coach just a team manager.
- LW updated the Committee on the L4 meet confirming that it still going ahead there are currently 5 swimmers signed up.
- Cara to have a chat with Emma about finding a lower squad DBS verifier.
- <u>Cara has had some requests from swimmers who are specifically asking for squads by name to join, she's thinking of trailing swimmers when the older squads are training to avoid confusion over the level of their swimmers.</u>
- Diversity and inclusivity training JH suggested asking as many members as possible to do the training.
- NS has asked for help to upload photos onto On Deck otherwise everything is ready to go post L3 meet.
