#### Other items:

- JD advised that the two parents who have volunteered to be Deputy Welfare Officers for Team Bath AS have now completed the 'Time to Listen' course. JD then left the meeting.
- March open meet. Approx. 600 swimmers have entered the meet due to take place on 13<sup>th</sup> to 15<sup>th</sup> March, 2020 at Millfield School. Currently short of officials for the Friday evening long distance events. [Action: DC to add CC to the Open Meet WhatsApp group] [Action: SG to email all parents re: raffle and cake donations required for meet]
- Head Coach update provided via SG: -
  - A number of squad movements are due to take place this week. Further re-structuring of squads may take place after Regionals. [Action: SP to ensure MK is aware of squad moves to ensure invoicing is in line]
  - Additional lanes have been secured at the University on a Saturday between 2pm and 3pm for the Academy
  - Masters. [Action: MK to look at costs and income for the Masters squad and provide feedback to the committee prior to the next meeting] [Action: SG to ask Karen B about details of any grants provided for the Masters squad]











- ASA renewals [Action: SP to provide MK with a contact at ASA for access to the finance reports required to ensure all payments are processed in a timely manner]
- Clinics. It was agreed that the target date for next clinic to be run should be Saturday 18<sup>th</sup> April, 2020. [Action: CC to discuss with Carolyn Nicholls]

#### AOB:

- L2 coaching course. Two people have expressed an interest in attending this course. The committee agreed for two bursaries to be used to fund these.
- Safeguarding course. Two young volunteers have expressed an interest in attending this course. TBC.
- Outstanding Academy fees. It was agreed by the committee that these should be chased up and paid in full. [Action: MK to contact individuals to chase payments]
- Network meeting. To be hosted at University of Bath on 16<sup>th</sup> March, 2020 by Andy Jack (Swim England Club Development Officer)
- Wavepower 2020. This was due to be published at the end of February 2020. It was noted that one of the parents may be willing to assist with reviewing and updating policies as necessary.
- Coronavirus (COVID-19). SG confirmed that currently the advice is to follow Public Health England (PHE) guidance. [Action: SG to issue email to all members regarding COVID-19] [Action: HW to talk to CA re: protocol for illness of swimmers and to remind parents (via email) of this and that absence due to illness will not impact on attendance]
