Abroad Camp Update

Chris and I have met to plan details of the Abroad Camp for October 2018.

An email with our initial request has been received by Steve Mellor at Sports Abroad and he has given us some prices. We need further information in order to make a decision.

The main choices are those that have more frequent flights from Bristol airport- Majorca/ Palma airport and Torremolinos/ Malaga airport.

There were 23 replies showing interest and enough to warrant having 3 lanes.

We plan to have 2 coaches and 2 team members. Training will need to be organised for them and this will be a priority in the months September to December 2017 to include Safeguarding, tM1 and TM2. This would be followed be an away meet or training in order to trial some of the procedures.

We have all the details from the previous camps including previous letters to parent and alerts, insurance company details etc and will discuss payment options with Julia. Loren will need to be involved with the risk assessments.

We will return to the committee with a costed before confirming a booking as it would commit the club to full costs. I will bring details of our initial request to the meeting.
