**Previous minutes** approved by all attendees and outstanding actions reviewed.

## Opening Remarks - NC

- NC provided visibility of AGM memo to be distributed to all club members later that evening
- NC confirmed that no new resolutions had been proposed
- NC confirmed only 3 members had submitted timely nomination forms and thanked them for their support

### Swimming Update - NC (on behalf of LW)

- TBAS swimmers did well at recent County IM & Relays event on 15<sup>th</sup> Oct
- Two performance swimmers added to the winter nationals list in 50 back & 800 free at recent Millfield & Chelsea Westminster meet
- Negative feedback received in regards organization and operations of above meet
- Upcoming meets:
  - o COB L3 Spooktacular 28-29 Oct (high attendance)
  - SW Winter Regionals 3,4 & 5 November
- Approval given for LW to attend Swim England Winter Champs









- Maintaining good swimmer numbers
  - Several have left but are quickly being replaced
  - Overall feeling is we're in a more positive position compared to same time 2022
  - Thanks to Cara again for her efforts with the academy trials etc

Action: LW to confirm Xmas swim schedule asap

#### Finance Update - GS

- Overall financial health of club more positive
  - o Confirmed that Sponsored Swim contributed £5k net
  - o All agreed cost of food at STV was expensive and alternative options to be looked at
- Instances where training has been cancelled for meets but the way the scheduling was done meant that we had lanes that we'd paid for which we couldn't cancel.

Action: LW to consider alternative approaches to using pool time when canceling sessions due to meets.

Discussion in regards bad debt which currently stands at c.£2,000. Club has followed due
process and is willing to afford one additional opportunity for sums due to be paid before
members required to exit club/before other members are not allowed to swim in meet.
