1. The meet will take place at UEA Sportspark on Sunday 23rd November 2025 and is licensed by Swim England at Level 4 under Licence No. 4ER[xxxxxx].
2. The meet will be run in accordance with Swim England Regulations, Swim England Technical Rules of Swimming and these conditions.
3. The competition is only open to members of Norwich Swan and up to 7 other invited clubs.
4. The promoter is Abby Chapman on behalf of Norwich Swan Swimming Club.
5. Medals will be awarded to 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> placed swimmers in each age group.
6. The age groups are: 8, 9, 10, 11, 12, 13 & over.
7. Age as at 23rd November 2025

8. The Female category is for birth sex females in accordance with Swim England's Transgender and Non-Binary Competition Policy. By entering the 'Female' category, a swimmer confirms that their birth sex is female.
9. The events will comprise 50m and 100m for all strokes and 100 Individual Medley
10. Age restrictions apply to the 100m events

**11. Swimmers may swim ONE distance per stroke**

12. The pool is 25m and anti-wave devices will be in place. AOE will be used and a secondary strobe for the starting system is available. Backstroke ledges are also available at this meet.

13. Heats will be swum as mixed age with swimmers seeded by entry times.

14. Over the top starts may be used at the referee's discretion.

15. Entry Times – swimmers must be slower than the event cut-off times published

16. Entries will be accepted on a first come first served basis until the meet is full.

**17. Closing date is Monday 27th October 2025.**

18. All entries must be made electronically. A Sports Systems entry file will be available

**19. Entry Fees: £5.00 per event**

20. Coaches' passes are free of charge. There will be no entry to poolside without a pass and passes must be worn at all times. All coaches, team managers and appointed volunteers attending poolside must be Swim England DBS checked, have a safeguarding certificate and suitable Team manager/Coaching qualification. This check can be obtained free of charge via

[https://www.swimmingresults.org/member\\_options/](https://www.swimmingresults.org/member_options/) The Club requests that all teams have sufficient coaches/team managers/chaperones on poolside to meet the requirements of the SE Team Manager, Coach and Chaperone policy.

21. Results will be supplied to Aquatics GB for entry into the national ranking database.

22. In accordance with Sportspark policy there is **NO photography or filming** allowed at this venue.

23. Mobile devices must not be used in the changing rooms under any circumstances.

24. All participants must observe the safety precautions in operation at Sportspark. Neither the Promoter nor Norwich Swan Swimming Club will be responsible for any loss or damage occurring during this meet.

25. The Data Protection Act 2018 requires us to provide you with certain information and to obtain your consent before processing data about you. Processing includes: obtaining, recording, holding, disclosing, destruction or retaining information. We require certain personal data for the purposes of making entries to the competition, managing the meet and the submission of results to Rankings. The information provided by you will be processed in accordance with the Data Protection Act 2018. Consent to process such personal data is deemed to have been given by the submission of the entry. Where the personal data of competitors, officials and coaches/team managers has been passed to us by a third party such as a club rather

than by the individuals themselves, we rely on the third party to ensure that consent has been obtained.
